RESEARCH DESIGN

Five jurisdictions from across Australia including New South Wales, Queensland, Western Australia, Victoria and the Australian Capital Territory, commissioned Woolcott Research and Engagement to investigate awareness and experience of information access rights amongst the general public.

A mixed mode survey amongst n=1785 Australian residents aged 18+ years was conducted between 26th June and 28th July 2021 utilising an online panel and Computer Assisted Telephone Interviewing (CATI). A breakdown of respondents by state/territory is displayed below:


Quotas were set by state, gender, age and location (metro/regional when applicable), and data was post-weighted to reflect the latest ABS population estimates.

IMPORTANCE OF HAVING THE RIGHT TO ACCESS GOVERNMENT INFORMATION








 Most respondents across the jurisdictions were aware of their right to access information from at least one of the agencies listed









SUCCESS IN ATTEMPTING TO ACCESS INFORMATION BY AGENCY






• Success in accessing information from state government entities and local councils somewhat varied across jurisdictions, however most were able to at least partially access the requested information




 The majority of respondents from all states/ territories agreed that agencies should be required to publicly report on artificial intelligence that was used inform decisions

SUMMARY

The vast majority of respondents across jurisdictions felt that their right to access information from government sources was very or quite important.

Most were aware of their right to access information from at least one of the agencies listed.

The proportion of respondents who had attempted to access information from a state entity varied somewhat across the states/territories. Rates of successfully accessing data also appeared to differ across the jurisdictions. State government agencies and local councils were the most common entities to request information access from, and most respondents were at least partially successful at doing so.

Respondents appeared to be the least successful at accessing information from state ministers and their staff.

There were high levels of agreement across jurisdictions that state agencies should publicly report on their use of AI and the information they maintain.
