IPC Annual Report 2021/22

Tabled in Parliament on 31 October 2022

Highlights:

- 40 strategic and regulatory initiatives finalised
- finalisation of 764 information access and privacy reviews and complaints
- 387 information access and privacy advices provided
- finalisation of 4 proactive information access audits and 1 privacy audit
- 112 advices provided to projects seeking funding under DRF
- Commissioners provided submissions to 9 reviews and inquiries by government, including 5 joint submissions
- 3,140 enquiries dealt with from the public
- 460,319 page views and a 4.8% increase in website visits
- 28 new publications, and 34 updated publications
- 4 new animations on citizens' rights & agency obligations under GIPA, PPIPA & HRIPA

Significant regulatory matters

- IPC has published the compliance reports for the agencies captured by its MoG GIPA compliance audit (Department of Enterprise, Investment and Trade & State Records and Archives Authority)
- IPC is finalising its audit related to acquisitions and disposals (Schedule 6 GIPA)
- IPC continues its progress with the research into the informal access pathway. A survey of sample agencies across the four sectors is complete, with UNSW undertaking a literature review
- A tremendously generous response from agencies.

IPC scan of the AI regulatory landscape

- The IPC published a high-level scan of the national and international regulatory landscape relevant to artificial intelligence (AI) with a focus on the preservation of information access and privacy rights
- Seeks to inform a future best practice regulatory approach for NSW
- The regulatory scan was requested by the Hon. Victor Dominello MP, Minister for Customer Service and Digital Government, Minister for Small Business, Minister for Fair Trading
- It considered:
 - governance models used internationally in regulating Al
 - an assessment of the risks to the fundamental information access and privacy rights in the use of AI
 - various treatment options available to address this risk

GIPA case study - Section 94 recommendation

Burcher v Transport for NSW

- The decision under review was the decision to refuse access to information under considerations 3(a), 3(b), and 6(1).
- The matter raised significant public interest factors in favour of disclosure regarding:
 - workplace health and safety (WHS) concerns
 - care and protection of the environment
 - the proper application of the law and legal processes
- Section 94(1) of the GIPA Act of the GIPA Act empowers the Information Commissioner to make a recommendation against the decision of an agency, when that agency has recommended that there is an overriding public interest against disclosure.
- Section 94(2) requires the Information Commissioner to consult the Privacy
 Commissioner before making a recommendation about a decision that concerns a privacy-related public interest consideration.

Information access case note

Eric Anthony Foster v Department of Planning and Environment [2022] NSWCATAD 235

- Applicant sought access to a list of addresses of social housing properties in specified allocation zones.
- Information which would not ordinarily be personal information under the GIPA Act may become personal information when combined with other information or enquiries.
