Privacy Agency Self-assessment Tool

- During PAW, the IPC released the revised IPC Privacy Agency Self-assessment Tool following a review and consultation with NSW agencies.
- The revised Tools build upon the previous version and now feature three components that work together to assess, track and plan for government maturity.
- The three components include:
 - A Maturity Matrix a framework that describes the difference areas of practice to be assessed and what maturity looks like at each level
 - **A Survey** the survey is used to collect data from various areas of the agency on the nature and effectiveness of their agency's governance practices
 - A Management Document this provides a space for agencies to record their level of maturity, as well as plan and track activities.

Privacy Commissioner Submission

Review of the Privacy Act 1988 – Review Report

This submission was provided in response to the Attorney-General's Department Review of the *Privacy Act 1988*. The Commissioner commented on various recommendations in the Report including:

- Scope and application of the Privacy Act, including amending the objects of the Act, updating the definition of sensitive information under the Act and amending the Act to enable Emergency Declarations to be more targeted by prescribing their applications to entities, classes of personal information, and types of acts and practices.
- **Protections**, including the development of standardised templates and layouts for privacy policies and collection notices, fair and reasonable personal information handling, the requirement of conducting Privacy Impact Assessments for activities with high risks, and the inclusion of high-level indicators in the Act of the types of decisions with a legal or similarly significant effect on an individual's rights.
- **Regulation and Enforcement**, including the Notifiable Data Breaches (NDB) Scheme and the Mandatory Notification of Data Breach (MNDB) Scheme, and the continued regulatory cooperation between the Commonwealth and States and Territories across Australia.
