- The A/Privacy Commissioner attended Panel Discussion hosted by OVIC and discussed how public servants can play an integral part in improving privacy practices

Significant regulatory matters

- The Acting Privacy Commissioner appeared as a witness and provided evidence at the NSW Parliament's AI Inquiry on 11 March.
- Submission made to the Victorian Department of Health, on the proposed amendments to the Health Practitioner Regulation National Law.
- Engaged with Transport NSW on the privacy impacts of their Seat Belt Camera Program.
- Engaged with DCS in relation to the review of ID Support's existing privacy code.
- Commenced its regulatory initiatives on compliance with the MNDB Scheme requirement to have a Data Breach Policy and extent Privacy Management Plan's have been updated

MNDB Update

- The IPC released its MNDB e-Learning module for Senior Leaders and is available via the IPC's e-Learning module.
- As shared in the IPC's PAW event (as at 7 May 2024), some insights from the Scheme:
 - There have been 31 notifications averaging about 1-2 per week
 - 77% of the notifications were in the State Government sector
 - Largest cohort of persons affected by a notified eligible data breach was 6,338
 - Human Error was the major cause for those notified
